**REPORT FROM DIRECTOR OF LICENSE & INSPECTIONS:**

Mr. Kucher stated that the Miller Trailer Park Remediation Plan that will be submitted to DEP is on the Bristol Township Website. There is a cliff note version available in License and Inspections.

President Pluta requested an update on the GIS Training. Mr. Kucher said they have been in touch with Pennoni but a date has not been set up. President Pluta said he would like to see it done before the end of September.

**REPORT FROM PUBLIC WORKS DIRECTOR:**

Mr. Lawson gave an update on the drainage problems from all the rain. There were no major blockages. When the pipes were put in 1960's they were adequate for the area. With all the building over the years there is more water runoff. They have been going through systems to find a way to make and easier flow. There are still a lot of trees down and they will be working on them. There will be a couple more streets paved, the milling will begin in October. Councilman Lewis said in his opinion there is a blockage in the storm pipe behind the homes on Spencer and Garfield. Mr. Lawson stated that a lot of that water comes from West Bristol and they are going to try to divert it, possibly to Route 413. Councilman Tucker questioned if Mr. Lawson is planning to install French drain. Mr. Lawson said yes in Winder Village.

**REPORT FROM CHIEF OF POLICE:**

Chief McAndrew said they have been experiencing a large increase in burglaries in the residential areas in Levittown. They are gaining entrance by unlocked windows and doors. He said people should make sure they keep their windows and doors are locked.

**REPORT FROM SOLICITOR:**

Mr. Sacco along with the assistance of Glen and Gary put together the Neshaminy Creek Watershed Ordinance that was adopted by the County and approved by the DEP. The Ordinance will be sent to the Township Planning Commission and the Bucks County Planning Commission for their review. It will be put on the agenda for vote at

the October 20<sup>th</sup> Council Meeting. The Bamboo Ordinance will be put on the agenda for the October 6<sup>th</sup> Council Meeting.

**OTHER:**

Councilman Lewis has been appointed to the Cable Committee as liaison. There is a Comcast Franchise agreement that is coming up. If there is anyone interested in sitting with Councilman Lewis on the Committee they should send their name in to the Chairman or the Manager.

President Pluta received an email from a lady requesting information on the taxing of apartments. Mr. Bartlett stated the apartments are taxed for regular property tax. When there is a turnover on tenants that information is turned over for the earned income tax.

**OPPORTUNITY FOR RESIDENTS TO ADDRESS COUNCIL:**

Mr. Ron Kenny of 205 Wistar Road said he was told two months ago that a speed trap would be done and speed enforcement sign would be placed on Wistar Road and nothing has been done. Mr. Lawson said they could maybe paint the road with lines so it looks like a speed bump. The speeding enforcement sign is broken and has been sent out for repair. Chief McAndrew said he instructed the Patrol Lieutenant to put up a computer generated unit that checks the speed the date the time and the vehicle. He sure the Lieutenant has done it the results may not be back yet.

Gallus Obert of Farmbrook spoke on speed bumps and suggested raising the fine fees. The lot behind Fitch School the lights are out. Queen Anne Drive has a speeding problem. The potholes that were reported still have not been fixed. Mr. Obert feels the roads should be milled before paving. He questioned if the Township is going to do anything about the flooding on Minot Avenue. Mr. Bartlett said it would be a multimillion dollar project to take care of the water in that area. Mr. Obert put a request for the paving bid specs and still has not received it.

Ms. Flaurette Chichilitti of Gridiron Road had a drain installed in front of her home and her front lawn and driveway was torn up. Public Works only put back what they tore

out. Everything was done without her ok, and when she was not home. The end of her driveway is half blacktop and half concrete. Mr. Lawson stated they had to dig her curb out and put 11 foot of curb back in, but did not black top over. Ms. Chichilitti requested the Township to replace the blacktop over the concrete. President Pluta stated that they would like to find out what is going on, and get back to her.

Mr. Ken Smith thanked everyone involved with getting the Jake brake signs up.

Mr. Smith said Public Works did a diligent job cleaning out the storm drains. There was a problem on a part of Radcliffe that the will need the camera truck that is not being used. Mr. Smith questioned if the State is going to make the Township change all the street signs to 6 inch letters. Mr. Lawson stated that there was talk about it. If the State enforces that it would cost approximately \$700,000.00, Gary Smith is looking into it.
