September 18, 2008

The meeting was called to order by President Davis at 7:00 P.M.

EXECUTIVE SESSION: personnel and litigation were discussed.

President Davis called for a Moment of Silence and Pledge of Allegiance.

Public comments will be taken as each item is addressed. General comments will be taken during Opportunity for Residents to Address Council.

Accommodation to Officer Wiser's K9 partner, Rommel, on service provided to the community. Rommel provided nine years of service to the community and physically he is now showing his age he will retire and to a home with a large fenced in yard. A plaque was presented.

EXECUTIVE REPORT:

Mayor Fenton reported Sunday October 5, 2008 at 10:45 A.M. is the Blue Mass at Saint Marks. It is to pray for Police, Fire Fighters and EMS Personnel. They are thanked for their service to the community.

Bristol Township Advisory Board wants to bring business to the area in this time of bad economy. Tax incentives are offered for blighted properties and promote the community. All interested should contact Jeff Bartlett.

A meeting should be scheduled with Foxwood Casino.

Rohm & Haas Company, 100 Independence Mall West, Philadelphia requesting Final Subdivision approval for property located inside the Bristol Plant, between Buildings 105 & 127 (Bristol Tech Center Site) (P/O Tax Parcel 5-56-01) in an M-2 Heavy Manufacturing zoned district of Bristol Township. The representative was Mr. Majors. A master plan is being prepared. The purpose is to convey the property to the Tech Center for additional parking for expansion planned next door. The Planning Commission recommends approval. Gary Smith stated an overall plan is requested. They will provide it. Nothing is wrong with the concept. There are no waivers. Councilman Monahan called for the motion to approve the request for Final Subdivision approval for Rohm & Haas Company, 100 Independence Mall West, Philadelphia for property located inside the Bristol Plant, between Buildings 105 & 127 (Bristol Tech Center Site) (P/O Tax Parcel 5-56-01) in an M-2 Heavy Manufacturing zoned district of Bristol Township. Mr. Kucher reported the proposed CVS at Oxford Valley Road is postponed until October 16, 2008 (waiting for a traffic study).

The Township is working on setting up the meeting regarding the landlord nuisances.

I am speaking with Gary Smith about setting plot lines on Newportville Road.

The Township is performing a blitz to ensure all nuisance properties are taken care of.

1309 Prospect is well into construction inspection are done.

Borderock Road-the residents who complained are setting up a meeting with the commercial property owner.

The Township sponsored Green Fest was an overall success. DCED Grant secured education money. The course will help establish guidelines for homeowners with established green homes.

Two Land Development projects came wanting woodland cleaning, trees must be replaced or money paid in lieu of. Council was asked to support the tree ordinance as required for land development. Our ordinance is lacking this now.

Summit Auto on Route 413- the Turnpike Commission is working with the contractors and Lower Bucks County Joint Municipal Authority to cap the water and sewer lines. They are starting now on the Newportville properties. Vice President Tarlini requested the tree replacement ordinance will be put in the packets. President Davis and Vice President Tarlini said it was okay to prepare the ordinance. Councilman Mobley stated the Shade Tree Commission should be involved.

Bob Monach of Fergusonville said I purchased a property five years ago and am looking to build for the past five years. I've waited five years. The Water Authority won't issue connections until Bristol Township does something about the sewer there. Your engineer approves but we can't do this until the moratorium is lifted. Mr. Kucher stated the property is in Fergusonville. The Township is looking into getting this resolved, myself, Vice President Tarlini and Dick Smith are involved. Mr. Monach said the moratorium is on; there is no information for the public. Mr. Kucher stated the moratorium was put on because of inflow and infiltration problems. A major complex and parts of Route 13 have been done to try to remedy the problem. Vice President Tarlini stated Bristol Township ourselves have not had a five year moratorium. Apparently, Bucks had it, now we have it. We are working on it, doing the Act 537 plan which will more than likely help us. President Davis stated leave your phone number with Mr. Kucher. Councilman Pluta stated you should get in touch with the Director of Water and Sewer.

REPORT FROM PUBLIC WORKS DIRECTOR:

Mr. Lawson reported a small amount of trees were down from the storm.

We are checking on complaints.

Paving is going well.

Weed and seed is thanked for the money for the playground equipment for Pacific Avenue.

Asphalt went up \$23.85 per ton (Barrett Asphalt). Mr. Obert stated the contract was not signed. Mr. Sacco stated when you award a bid the contractor must adhere to the bid process. I will check on it. This is the first I heard about this.

President Davis stated we are looking for people for the Economic Advisory Board again. Mr. Bowen responded I will be part of the committee. Some of the employees still here today are exceptional. We can't have obstinacy when people are coming here. President Davis stated Mr. Kucher and Mr. Dippolito will meet with you. Vice President Tarlini stated two years ago during the budget the fees were in line with other townships.
- 2. Bob Monach Sr.-did not speak.
- 3. Gallus Obert-stated Mr. Hayduk has been ill. I have a concept to hand out which shows a lot of little skate parks then you would have one in each neighborhood. You could have five of these for \$100,000.
- 4. Ken Smith-said Radcliffe Street is a State road and they are taking care of it.
- 5. Jake Tryon-said trucks are parked on a lot on Route 13, why is this allowed? Mr. Kucher responded we are now doing a blitz on Route 13. This is something new. We will take it to the district justice; they will first be given ten days to get the trucks out of there. Mr. Tryon stated the trailer is still on State Road. Mr. Kucher responded he has an appeal to the Zoning Hearing Board. He should vacate that site I will have it done.
