### REPORT FROM MANAGING DIRECTOR:

Mr. Bartlett reported the tree lighting will be December 3, 2009.

The Census Bureau has contracted the Senior Center to use as a building for work. They are requesting a waiver of fees. They will have one table with two people working. Councilman Monahan called for the <u>motion</u> to approve the request for waiver of fees for the Census Bureau for use of the Senior Center. Second by Councilman Greer. Poll: all ayes. Motion approved.

Mr. Bartlett said Sergeant Burns and me worked with Delaware Valley Regional along the Levittown Parkway. We did a walking tour with representatives from the Department of Transportation, Penn dot

and the bicycle coalition. Penn dot did a full report with recommendations. The report will be submitted. More lighting and no left turn in some areas is planned.

Pennvest gave a nine million dollar loan. We need to accept the offer of the loan and move ahead with the project. Vice President Pluta called for the <u>motion</u> to accept the offer for a nine million dollar loan from Pennvest. Second by Councilman Greer. Poll: all ayes. Motion approved.

The DCNR wanted some plant life preserved. We are working with them for approval. We will submit to the Conservation Group after. We are in receipt of the water supply approval. Public sewer review is in the process as we speak. Gary smith stated water, sewer, sanitation and sediment control is outstanding. Councilman Monahan called for the motion to approve Joseph DiEgidio Sr., P.O. Box 945, Bensalem, PA requesting Final Land Development approval in order to construct an industrial building on the property located at the intersection of Edgely Road & Runway Road, Levittown (Tax Parcel #5-70-41-2) in an M-1 Light Manufacturing zoned district of Bristol Township. Second by President Tarlini. Poll: all ayes. Motion approved.

Box 1619, Levittown, Pa. requesting Conditional Use approval in order to operate a vintage, antique, classic exotic car museum and car sales, auto and truck repairs and collision center, offices and sit down restaurant on the property located at Bath Road & Veterans Highway, Bristol (Tax Parcels #5-20-16, 5-20-16.1, 5-20-17, 5-20-18, 5-20-22 & 5-20-23) in a C-Commercial w/TC Town Center Overlay zoned district of Bristol Township. Mr. Sacco stated this motion would approve a separate lot for the restaurant. Mr. Marty, representative said the plan is to use the restaurant part for vintage sales until the restaurant is found. Variances were received from the Zoning Hearing Board. This was used by Weed Chevrolet for the use of sale and repair of cars. The offices are also a part of this. Mr. Sacco stated lot two is not to be used for car sales except for antique vintage. President Tarlini said if that goes well what would make you want the restaurant? Mr. Leipziger said I'm trying to bring a theme restaurant. There is plenty of room. There is not enough inventory to fill the area with that type of vehicle. Vice President Pluta stated I am concerned with the separation between them and the residents. Mr. Marty stated we will leave the fence and put in trees. Vice President Pluta stated I am still concerned. Councilman Monahan called for the motion to continue on the waivers. Second by Councilman Greer. Vice President Pluta stated I want more concern with the community residential area. The barrier should be there for the life of the project. I have concern for the residential side of it. Mr. Leipziger stated we understand what the Township engineer requested on the site. Vice President Pluta stated this is a good project but the history of commercial and residential abutments results in a lot of problems. Mr. Marty stated there will be dense trees, you can't see though them. Mr. Sacco stated November 17, 2009 Pennoni wrote a letter is that a will comply? Mr. Marty responded yes. Councilman Greer called for the motion to approve Robert Leipziger, P.O. Box 1619, Levittown, PA requesting Preliminary and Final Land Development approval in order to operate an auto dealership on the property located on Veterans Highway & Ford Road, Bristol (Tax Parcels #5-20-16, 5-20-16.1 and 5-20-17) in a C-Commercial zoned district of Bristol Township. Mr. Marty, the representative said the proposed subdivision of the site is for lot one to be used as an auto truck repair and vintage museum sales and lot two to be used as a restaurant, show room and offices. The rear of the property is an auto service garage. The restaurant would have to come for land approval. Approval was received by the Planning Commission. Mr. Leipziger hopes to create new jobs. One house exists and already conforms. The Bucks County Conservatory District and DER gave reviews. Bucks County conservatory wanted stormwater at the rear. Mr. Smith agreed to the plan for this verbally. Documentation is to be received. There is a moratorium on sewer. We are not

pressing to build now because of the economy. We want to sell the remaining house and have the parcels subdivided before the sale. Gary Smith and the Planning Commission reviewed and a couple of waivers were required. Sidewalks and curbing were agreed to a fee in lieu of. The conservatory district is outstanding. There are no objections from the adjoining neighbors and there is a letter signed to show no objections. The recreation community facility will be a fee in lieu of in the amount of \$3,000 that was agreed to. The water and sewer certification and adequacy of tying in will be outstanding due to the moratorium. We will go ahead subject to getting the permits. A waiver was received from the Planning Commission for manmade features. Councilwoman Davis called for the motion to approve Robert Leipziger, P.O. Box 1619, Levittown, PA requesting Preliminary and Final Land Development approval in order to operate an auto dealership on the property located on Veterans Highway & Ford Road, Bristol (Tax Parcels #5-20-16, 5-20-16.1 and 5-20-17) in a C-Commercial zoned district of Bristol Township. Mr. Marty, the representative said the proposed subdivision of the site is for lot one to be used as an auto truck repair and vintage museum sales and lot two to be used as a restaurant, show room and offices.
